Sub: Job Opportunities - Trained Technicians/ Engineers/ Installers under PMSG: MBY

Dear Sir,

This is to bring to your attention the discussions held in the Chairmanship of Secretary MSDE wherein the focus was laid on ensuring employability of the trained candidates and enable their employment for meeting the requirements under PMSG: MBY, amongst others. In this regard, REC has been holding discussions with various Solar PV manufacturers and vendors to raise the awareness of the capacity building activities being taken up under PMSG: MBY, seeking their hiring requirements and urging them to hire the manpower trained under PMSG: MBY.

In accordance to the same, as discussed offline and also emailed on 2nd Jan, 2024 to DGT, there are a few firms requiring significant quantum of trained manpower for their operations under PMSG: MBY. It is to inform that REC team has been in continuous touch with them to enable sourcing of candidates. In this regard, emails have been sent to the trained Surya Mitras from last 3 years, as well as to the candidates trained by DGT under PMSG: MBY. The hiring firm has also published advertisements in the newspapers and REC has directly reached out to the candidates through emails, but the hiring firm has informed that against their requirement of 543 candidates (M/s Urja Strot – details at Annex II) across the country, only 33 applications were received by them. Additionally, REC has emailed to various ITIs as well as directly approached many ITI heads to encourage their trained manpower for considering this available opportunity, but the hiring agency is still facing difficulty in getting the requisite interest from candidates. Further, M/s Waaree has highlighted the requirement of ~1,008 trained candidates across the country, with their channel partners (details at Annex I). The list of district-wise trained candidates has also been made available to both of these firms.

In above regard, it is noted that DGT has trained ~30,000 manpower under PMSG: MBY, however to enable their employability, the details of such hiring requirements may be made known to the trained candidates/ Training Institute heads, of the available opportunities, as under:

- 1. Waaree Energies: 1,008 Solar Installers, with details at Annexure-I.
- 2. Urjastrot Private Limited: 543 Solar Installers, with details at Annexure-II.

In light of the above, it is requested that:

- DGT being the overall training agency for installers / engineers/ technicians, may also take up with their training institutes to highlight the available opportunities and encourage them to utilize these opportunities,
- DGT may coordinate with their institute heads to regularly collate the details of the employment generated for the candidates trained by them under PMSG: MBY, for reporting the same to MNRE
